Counternarcotics Engagement with Oceania

During the months of July and August, 2013, several Joint Interagency Task Force West events took place in the Oceania region. There has been a long history of cooperation between JIATF West and the many island nations of Oceania as JIATF West seeks to improve partner nation counterdrug capabilities with specialized law enforcement training and infrastructure projects. The smaller populations of Oceania nations mean a closer working relationship between host nation governments and members of JIATF West. It is not uncommon for Ministers of Justice, Ambassadors, and even Presidents of nations to welcome trainers from JIATF West or speak at closing ceremonies.

The first event this summer was a Transnational Crime Workshop held in July on the island nation of Palau attended by the Vice President of Palau, Antonio Bells, and the Attorney General, Minister Johnny Gibbons. This was followed by two weeks of training with the Small Craft Maintenance Training Team (SCMTT) in the Federated States of Micronesia (FSM) in early August. Members of JIATF West were welcomed by President Manny Mori, as well as U. S. Ambassador, Honorable Dorothea-Maria (Doria) Rosen, along with the Secretary of Justice, Ms. April Skilling.

Transnational Crime Workshop in Palau

JIATF West recently held a 2-week transnational crime workshop on the island of Palau. The workshop took place between the 15th and the 26th of July, 2013 and was attended by various Palau law enforcement agencies including the Palau National Police, Airport Police, Immigration Police, Customs Police, and Postal

Inspectors.

Topics presented in the workshop included interviewing techniques, crime scene administration, crime scene photography, evidence handling interdiction, precursor chemicals, and operations planning. Instructors for the course consisted of five members of the U. S. Federal Bureau of Investigations, three Drug Enforcement Agency agents, one Naval Criminal Investigative Services agent, and one U. S. Postal Inspector from Guam. The first week of training was presented by the FBI and the second week by the DEA.

Counternarcotics training efforts by JIATF West are well recognized by the Palauan Government. The Vice President, Antonio Bells, and the Attorney General, Minister Johnny Gibbons attended the closing ceremony. In Palau, the Vice President is also the acting Minister of Justice. U. S.

Ambassador, The Honorable Helen Reed-Rowe, was also in attendance (Ambassador Reed-Rowe is Palau's first ever U. S. Ambassador).

The workshop was enthusiastically received by all of the participants.


Thirty one Palauan law enforcement members completed the two week long

workshop.

According to training liaison LT Franz Federschmidt, USN, "Some of the feedback provided by Palauan law enforcement indicates they wish the training was more than two weeks and held semi-annually." This was the third time JIATF West ran a transnational crime workshop of this type in Oceania. The two previous events attended by Palauan Law Enforcement took place in Micronesia in August of 2011 and in Palau in May of 2010.

The Republic of Palau is an island nation made up of a chain of 250 islands east of the Philippines.

TIATF West Task Force Representative to Oceania, LCDR Aja Kirksey, USCG, recently attended the 42nd Pacific Islands Chiefs of Police Conference (PICP) in the Cook Islands. The conference took place on August 26, 2013 on the southern island of Rarotonga, located about 1800 miles northeast of New Zealand between America Samoa and French Polynesia. The goal of the PICP is to improve policing in the Pacific by providing a forum to share ideas and information on crime and policing, and coordinating training and development activities for its members. Attended by the Oceania TFR for many years, the PICP Conference is a rare opportunity to network with numerous key Pacific island law enforcement officials while

observing the unique cultural challenges of the region in a concentrated setting.

The theme of the conference, "Preventing crime through information management" set the tone for the three-day conference. In conjunction with this gathering, the Pacific Transnational Crime Network Board of Management held their annual meeting, where they further discussed the challenge of secure information sharing between countries. The incoming PICP Chair historically hosts the conference on their home island. During the conference, Cook Islands Commissioner of Police, Maara Tetava, assumed the Chair duties from Solomon Islands Acting Commissioner of Police Juanita Matanga.

Cook Island's 42nd Pacific Islands Chiefs of Police Conference (PICP)

The PICP currently has 20 members, represented by the Chief or Commissioner of Police of their national police service. The conference was also attended by presenters and observers from the Drug Enforcement Administration, the Australian Federal Police. the New Zealand Police, the and Pacific Transnational Crime Coordination Center, the Pacific Island Forum, the **Pacific Immigration Directors** Conference, the Pacific Prevention of Domestic Violence Programme, the Pacific Islands Law Officers' Network, and the Women's Advisory Network.

Rarotonga is the largest of the Cook Islands, surrounded by a coral reef and a beautiful lagoon of clear, calm, turquoise water. Rarotonga's main road circles the island, following the coastline for 20 miles. The Cook Islands and New Zealand have a free association relationship, but the Cook Islands are still an independent and sovereign state. Over 110,000 tourists visit the Cook Islands per year, primarily from New Zealand, Australia, Europe, and the United States. --

Integrated Maritime Skills Training in the Federated States of Micronesia

TIATF West's Small Craft Maintenance Training Team (SCMTT) conducted a two week long training mission with the Federated States of Micronesia's National Police (FSM-NP) in August. The

training took place at two different locations with

the first part at

FSM-NP's

headquarters in

the city of Kolonia

located on the

island of

Pohnpei. Pohnpei island is part of the State of Pohnpei (FSM is made up of four States that are each made up of a group of islands). The second part of training was a three day culmination exercise conducted off islands located in the state of Chuuk.



The training was designed to provide fundamental maritime law enforcement to support FSM National Police counterdrug efforts. Although the National Police Maritime

> Wing is a very operational unit, most police officers have had limited maritime law enforcement training

due to the remoteness of their island nation. FSM National Police members were very appreciative for the

training. According to Officer in Charge, LCDR Stephen Bower, USN, "FSM law enforcement members

demonstrated significant enthusiasm while training full days and on weekends." Although JIATF West has previously organized law enforcement training in the FSM, this was the first ever SCMTT led training.

Integrated Maritime Skills Training in the Federated States of Micronesia

During the training in Pohnpei and Chuuk, SCMTT instructors covered a variety of law enforcement topics including, maritime safety,

officer awareness, interview techniques, evidence collection and reporting, handcuffing, vessel boarding procedures, communications skills, basic defensive techniques, human trafficking, and first aid. Training included practical demonstrations by SCMTT members as well as open ocean drills in Pacific Class Patrol Boats.

Instruction usually took place in
the morning followed by
hands-on instruction that
allowed FSM law enforcement
an opportunity to get instructor
feed back while practicing. Law
enforcement techniques were
practiced in a variety of
scenarios including cover and
concealment, movement as a
team, space clearing, and initial ship boarding.

future partner law enforcement efforts with FSM to help promote stability in the Asia-Pacific. --



Royal Thai Police Seize 6 Million USD of Meth after JIATF West Training

Chiang Rai Thailand, 16 August 2013 – Royal Thai Police officers seized 970,000 pills of methamphetamine hidden in a secret compartment of a vehicle attempting to pass through Chiang Rai's Tham Pla checkpoint. The seizure took place just hours after police completed special highway checkpoint narcotics training organized by Joint Interagency Task Force West. The pills, referred to as "yaba" in Thai, had a street value worth 6 million US dollars.

Camp H. M. Smith, 9 Aug 2013 - Ambassador William R. Brownfield, Assistant Secretary of the Bureau of International Narcotics and Law Enforcement Affairs visits Joint Interagency Task Force West at U. S. Pacific Command Headquarters. This was Ambassador Brownfield's first visit to JIATF West. AMB Brownfield has had an extensive career in the field of International Narcotics and Law Enforcement and met with RDML Rendon and JIATF West staff for an office call and round table discussion. The meeting was held in the JIATF West conference room with presentations by LtCol Duncan Buchanan, USMC, and Mr. Bill Treadway. After the presentations, a luncheon was held in honor of AMB Brownfield at the USPACOM Flag Mess.

Ambassador Brownfield was sworn in as Assistant Secretary for International Narcotics and Law Enforcement Affairs (INL) on January of 2011. Hon. Brownfield is responsible for State Department programs combating illicit drugs and organized crime and currently manages over 5000 employees in over 80 countries with a portfolio of over 4 billion dollars.

Some of Ambassador Brownfield's previous work in Washington included the Deputy Assistant Secretary for Western Hemisphere Affairs, Deputy Assistant Secretary for International Narcotics and Law Enforcement, Director for Policy and Coordination in INL, Executive Assistant to the Bureau of Inter-American Affairs, Member of the Secretary's Policy Planning Staff, and Special Assistant to the Under Secretary for Political Affairs.

Ambassador Brownfield holds the personal rank of Career Ambassador, the highest rank in the U.S. Foreign Service. He has received the Secretary of State's Distinguished Service Award and the Presidential Performance Award three times. Ambassador Brownfield is a graduate of Cornell University (1974) and the National War College (1993). He attended the University Of Texas School Of Law (1976-78). He speaks Spanish and French. He is a native of the State of Texas.

Samoa's new Chargé d'affaires

Mr. Peter J. Ganser, a diplomat with the U. S. Foreign Service and former Commander in the U. S. Coast Guard paid a visit to Joint Interagency Task Force West prior to assuming duties as the new chargé d'affaires to Samoa in September of 2013. On the 21st of August, Mr. Ganser had an office call with U. S. Coast Guard Rear Admiral James Rendon, and viewed presentations by staff members regarding JIATF West's counterdrug efforts in Oceania.



The diplomatic title, "chargé d'affaires", a French phrase meaning, "in charge of matters" is a diplomat who heads a diplomatic mission such as an Embassy in the absence of an Ambassador. A chargé d'affaires is usually a person who is already working as a diplomatic Secretary, Counselor, or Minister.

Mr. Ganser represents Samoa as the chargé d'affaires whenever the current Ambassador to New Zealand and Samoa, Ambassador David Huebner, is not in Samoa. A chargé d'affaires has the same privileges and immunities of a regular Ambassador.

His most recent assignments have been as Deputy Consul General, Islamabad, Pakistan and as Chief, Consular Section, Harare, Zimbabwe. --

In Tr. Earl Hampton took over duties as Deputy Director of Joint Interagency Task Force West in September, 2013, from incumbent William Roig who retired in August. Prior to becoming the new Deputy Director, Mr. Hampton served as the JIATF West representative to Indonesia and Malaysia.

Aside from his recent work as a Task Force Representative to Indonesia and Malaysia, Mr. Hampton brings with

him his experience as a US Navy Captain with over 30 years of service. In the Navy, he was a Naval Flight Officer and served as the Commanding Officer to several Air Patrol groups in Japan, Spain, and Hawaii. The numerous missions served by Mr. Hampton led him to work throughout the Pacific, the Indian Ocean, and the Middle East including Afghanistan and the Philippines in support of **Operation Enduring** Freedom.

Mr. Hampton's educational qualifications include an undergraduate degree from the U.S. Naval Academy, a Master of Arts in International Relations from the Fletcher School of Law and Diplomacy at Tufts University, and a Master's of Science in National Resource Strategy from the Industrial College of the Armed Forces (ICAF) at The National Defense University in Washington, DC.

Mr. Hampton is no stranger to Hawaii having served at Marine Corps Base Kaneohe Bay as the Commanding Officer for Patrol Squadron NINE and several posts at U.S. Pacific Command. His work at USPACOM includes working as the Chief of Strategy and Assessments, Director to the Joint Interagency Coordination Group (JIACG), and as the Director of the Joint Operations Center.

Earl Hampton was born in Olongapo City, Philippines where he enlisted in the U. S. Navy after graduating high school. He can speak Tagalog, Spanish, and a little Mandarin. He is married and resides on Oahu with his wife and two children.

> the DoD pertaining including programs to train and equip foreign military forces; American counterinsurgency and irregular warfare capabilities; stability operations; disaster response and humanitarian assistance; and the

Mr. Singh has also worked in Sri Lanka, where he ran a Ford Foundation program on minority rights and conflict in Bangladesh, India, Nepal, Pakistan. Mr. Singh holds degrees from the University of California at Berkeley and Columbia University.



Recipe of the Month - Butternut Squash Soup with Fontina Cheese Crostini

Ingredients

Soup

2 tablespoons butter, at room temperature

2 tablespoons extra-virgin olive oil

1 medium onion, chopped

1 medium carrot, peeled and chopped into 1/2-inch pieces

3 cloves garlic, minced

3 1/2 pounds butternut squash, peeled, seeded, and cut into 3/4-inch pieces (about 7 to 8 cups)

6 cups low-sodium chicken stock

 $1/4~{
m cup}$ chopped fresh sage leaves

Kosher salt and freshly ground black pepper

Crostini:

1/2 baguette, sliced diagonally into 1/2-inch thick slices

Extra-virgin olive oil, for drizzling 2 tablespoons chopped fresh sage leaves 1 cup (2 ounces) grated fontina cheese Kosher salt

Directions:

In an 8-quart stockpot, add the butter and oil and melt together over medium-high heat. Add the onion and carrot and cook, stirring occasionally, until the onion is soft, about 5 minutes. Stir in the garlic and cook until aromatic, about 30 seconds.



Add the squash and the chicken stock. Bring the mixture to a boil and add the sage. Continue to boil until the vegetables are tender, about 20 minutes. Turn off the heat. Using an immersion blender, blend the mixture until smooth and thick. Season with salt and pepper, to taste. Keep the soup warm over low heat.

For the crostini: Put an oven rack in the center of the oven. Preheat the oven to 400 degrees F. Arrange the bread slices on a baking sheet. Drizzle with olive oil and sprinkle with sage. Sprinkle the cheese on top and season with salt, to taste. Bake until the cheese has melted and the bread is light golden, about 6 to 8 minutes.

To serve, ladle the soup into bowls and garnish with the cheese crostini.

Cook's Note: The cooked vegetable mixture can also be pureed (after cooling for about 5 minutes) by ladling, in batches, into a food processor or blender and blended until smooth.
